

THE CORPORATION OF THE MUNICIPALITY OF HURON SHORES

BY-LAW # 08-51

BEING A BY-LAW OF THE CORPORATION OF THE MUNICIPALITY OF HURON SHORES TO ADOPT THE OFFICIAL PLAN.

WHEREAS The Municipal Act 2001, c. 25, s. 5 (3) as Amended, requires a municipal council to exercise its powers by by-law, unless the municipality is specifically authorized to do otherwise;

AND WHEREAS under the Planning Act R.S.O. 1990 as Amended, under Section 17 (22) Council desires to adopt an Official Plan for the Municipality of Huron Shores;

NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE MUNICIPALITY OF HURON SHORES ENACTS AS FOLLOWS:

1. That the Official Plan and all amendments thereto for the Iron Bridge Joint Planning Area as originally approved by the Minister of Municipal Affairs and Housing on May 21, 1985 are hereby repealed.
2. That By-law No. 84-2 and 84-3 for the former Village of Iron Bridge, adopting the Iron Bridge Joint Planning Area Official Plan on January 3, 1984, and on January 5, 1984 respectively, is hereby repealed.
3. That By-law No. 86-4 for the former Village of Iron Bridge, adopting the Iron Bridge Joint Planning Area Official Plan Amendment Number One, on March 4, 1986, is hereby repealed.
4. That By-law No. 1-84 for the former Corporation of the Townships of Day & Bright Additional adopting the Iron Bridge Joint Planning Area Official Plan on January 5, 1984, is hereby repealed.
5. That By-law No. 6-86 for the former Corporation of the Townships of Day & Bright Additional adopting the Iron Bridge Joint Planning Area Official Plan Amendment Number One, on May 8, 1986, is hereby repealed.
6. That the Official Plan for the former Township of Thessalon as originally approved by the Assistant Deputy Minister of the Ministry of Municipal Affairs on February 16, 1993, is hereby repealed.
7. That By-law No. 6-91 for the former Township of Thessalon, adopting the Official Plan on August 6, 1991, is hereby repealed.
8. That the Official Plan for the Municipality of Huron Shores consisting of the attached maps and explanatory text, is hereby adopted.
9. That this By-law shall come into force and take effect on the day of the final passing thereof subject to the requirements of the Planning Act.
