BY-LAW # 12-21

BEING A BY-LAW OF THE CORPORATION OF THE MUNICIPALITY OF HURON SHORES TO AMEND THE HURON SHORES OFFICIAL PLAN TO BE KNOWN AS HURONS SHORES OFFICIAL PLAN AMENDMENT NO. 1

WHEREAS Schedule A4 to the Huron Shores Official Plan adopted by Council by By-law 08-51 was inadvertently not included as part of the Official Plan Document and Schedules approved by The Ministry of Municipal Affairs and Housing December 16, 2011;

AND WHEREAS Council deems it expedient to amend the Official Plan to include the schedule as it was intended to be part of the plan as presented at all public meetings during the process and implementation of the noted document;

AND WHEREAS the Ministry of Natural Resources and Ministry of Municipal Affairs and Housing require that the Wildlife Feeding area along the Mississagi River be identified on the Official Plan Schedules;

NOW THEREFORE Council ENACTS AS FOLLOWS:

1. THAT Huron Shores Official Plan Amendment No. 1 to the Official Plan attached hereto and forming a part of this By-law be adopted;
2. THAT the Clerk is hereby authorized and directed to make application to the Ministry of Municipal Affairs and Housing for Approval of Huron Shores Official Plan Amendment No. 1 to the Official Plan;
3. THAT this By-law shall come into force and take effect on the day of final approval.

**AMENDMENT No. 1
TO THE
Municipality of Huron Shores
OFFICIAL PLAN**

PURPOSE

1. SCHEDULE A3a as attached hereto is amended to identify the Wildlife Feeding Area along the Mississagi River.

2. SCHEDULE A4 as attached hereto is added to the Huron Shores Official Plan and amended to identify the Wildlife Feeding Area along the Mississagi River.

LOCATION

This amendment covers all of the lands shown on Schedule A4 and the area outlined and labeled as Wildlife Feeding Area on Schedules A3a and A4.

BASIS

This amendment is necessary because Schedule A4 was inadvertently not included within the approved Official Plan. In addition the Wildlife Feeding Area as outlined by the Ministry of Natural Resources was not added to Schedules A3a and A4.

Council now considers it desirable to amend the Official Plan to add Schedule A4 and to have Schedules A3a and A4 show the Wildlife Feeding Area abutting the Mississagi River.

DETAILS OF THE ACTUAL AMENDMENT & RELATED POLICIES

A4 and the Wildlife Feeding Area on A3a, as shown on the attached Schedules will now form part of the Official Plan for the Municipality of Huron Shores.

INTERPRETATION

The provisions of the Official Plan as amended from time to time will apply to this Amendment.
