AND WHEREAS the individual townships, prior to amalgamation, entered into agreements with the Province to administer the OHRP;

AND WHEREAS the Province cancelled the program in 1993;

AND WHEREAS, in 2005, in an attempt to collect the outstanding loans, Council passed a resolution to write off all outstanding interest, conditional upon commitment by the homeowner to pay the principal balance;

AND WHEREAS all but one loan, conveyed to the Municipality of Huron Shores as of amalgamation January 1999, has been recovered although several attempts have been made to collect it;

AND WHEREAS the program guidelines provided a process whereby a loan may be written off as uncollectible;

NOW THEREFORE BE IT RESOLVED THAT Council, as per the recommendation of Treasury in a report dated November 27th, 2015, directs that **Ontario Home Renewal Program Loan #57-29-26** in the amount of \$2,480.42 be written off as uncollectible;
