Deputy Mayor Wedgwood declared that the purpose of this Public Meeting as recommended under the *Planning Act* is to hear comments in support of, or objection to, a proposed **Consent Application, File 2019-C-02**, that has been received for Lot 3, Lot 1 RCP H788 E of 1R3532 & N of 1R8890, in the geographic Township of Thessalon, in the Municipality of Huron Shores, to sever a 5.6 hectare (14 acre) parcel of land, from the retaining 14.5 hectares (36 acres) located at **136 Ingram Road**.
