Contract Terms and Conditions:

If the above Interment Rights have not been used the *Purchaser* may in writing to the Cemetery Owner, within thirty (30) days from the signing of the contract, cancel this contract and receive a full refund.

Written consent of all surviving Rights Holder(s) and any other required documentation as set out in the cemetery by-laws is required for interments, disinterment, and the placement of markers, monuments, inscriptions or ceramic photos.

Private resale of Interment Rights after 30 days, as per Cemetery By-laws #01-28 and 13-24 is PROHIBITED. The Purchaser or if deceased, the Interment Rights Holder(s) may sell the Interment Rights back to the Cemetery Owner at the current value on the cemetery price list *minus* the Care and Maintenance component, *provided* there have been no interments or memorializations and the Interment Rights have been paid in full. The original Interment Rights Certificate must be returned to the Cemetery Owner at the time of re-sale or transfer and the Transfer Form must be completed and duly signed by the Purchaser *or* all Interment Rights Holder(s) as listed in the contract *or* their appointed representative as per original signed letter on file.

Subdivision of Interment Rights:

No Rights Holder(s) may sub-divide and sell or transfer a portion of an Interment Rights unless approved by the Cemetery Owner.

An Interment Rights Certificate will not be issued until such time as all fees have been paid in full.

Privacy Policy:

The Purchaser acknowledges and provides consent to permit the Cemetery Owner to collect, use and disclose your personal information in accordance with the requirements under the FBCSA and Ontario Regulation 30/11 for information within the cemetery/crematorium public register. The Purchaser also understands that the Cemetery Owner does not rent or sell personal information to third party organizations.
